

GENERAL TERMS AND CONDITIONS FOR PARTICIPATION IN THE CONFERENCE "ENVIRONMENTAL ASSESSMENTS AND THE EUROPEAN GREEN DEAL '22"

1. GENERAL REGULATIONS

The General Terms and Conditions govern the purpose and conditions under which the conference "Environmental Assessments and the European Green Deal '22" (hereinafter: the Conference) organized by the Croatian Association of Experts in Nature and Environmental Protection (hereinafter: HUSZPO) will be held, the manner of presentation and publication of papers from the Conference, the conditions of participation and the procedure for possible cancellation before its implementation.

The General Terms and Conditions are an integral part of the registration for each HUSZPO Conference.

An individual who registers for the Conference, fully, irrevocably and unconditionally accepts these General Terms and Conditions, which are published on the Conference website.

2. REGISTRATION

Registration for the Conference is done by filling out the registration form on the Conference website, where the participant must provide their information (name, surname, company, PIN/VAT ID, address, e-mail address, role in the company and telephone number). By entering the above information, the participant guarantees that the information is correct and complete. Group registrations cannot be processed online, so each participant must use a separate registration form.

Registration is required before the Conference because the number of places is limited. An individual can also register other persons from the same company by sending a list of names and surnames to konferencija@huszpo.hr.

3. REGISTRATION FEE

Registration fee includes: participation in the Conference, electronic edition of the Proceedings, printed edition of the Proceedings. welcome drink, coffee breaks, lunches, gala dinner and excursion.

4. PARTICIPATION IN THE CONFERENCE

Participation in the Conference is charged and preliminary application is required. Any costs that are not covered by the registration fee and are incurred as a result of the application or participation in the Conference will be borne by the participant.

Attendance at the Conference is voluntary. The Conference is organized in accordance with current epidemiological measures. Should the epidemiological measures so require, during the Conference, 14-17 September 2022, participation will be allowed with the presentation of a valid EU digital COVID certificate. COVID-19 conditions of participation will be opportunely announced on the Conference website and by e-mail to registered participants. It is possible, with the consent of HUSZPO, to transfer the participation right in the Conference to another participant by written notice sent to HUSZPO by email at konferencija@huszpo.hr no later than by 12 September, 2022.

5. CONFERENCE PROMOTION

Conferences are covered by the media and are photographed and audio and video recorded by HUSZPO. Recorded audio and video materials and photos of the Conference may be published on the HUSZPO website, social networks where HUSZPO maintains profiles or pages, as well as in other media for the purpose of event information.

6. PUBLICATION OF PAPERS FROM THE CONFERENCE

Participants have the right to submit one or more scientific papers for presentation at the Conference. Abstracts should be submitted to HUSZPO by the deadline and in the manner indicated on the Conference website. Presentations are to be sent to HUSZPO by the deadline and in the manner indicated on the Conference website.

After valid and timely submission of the abstract, HUSZPO will perform I) review of the abstract II) proofreading of the abstract III) publication of the final version of the abstract in the Book of Abstracts in digital and printed form IV) publication of the oral presentations of the paper in pdf format on the Conference website.

At the author's request, the complete paper will be published in a selected scientific-professional journal, information on which will be published on the Conference website.

7. CANCELLATION OF THE CONFERENCE BY HUSZPO

HUSZPO reserves the right to change the content of the Conference and to postpone or cancel the Conference in case of insufficient number of participants, force majeure or any other reason. HUSZPO will notify the registered participants about cancellation of the Conference no later than on the day before the Conference by e-mail or telephone.

HUSZPO reserves the right to deny participation or to ask a person to leave a Conference in case of disturbance or inappropriate behaviour throughout the Conference duration.

In cases above, HUSZPO shall not be held responsible for any damage caused to the participant.

8. CANCELLATION OF PARTICIPATION IN THE CONFERENCE BY PARTICIPANTS

The participant may cancel their attendance in the Conference in writing, to the e-mail address: konferencija@huszpo.hr no later than 1 September, 2022, with the right to a full refund of the registration fee. Refunds will be made upon completion of the Conference.

In case the participant withdraws from attending the Conference in a manner other than described above or after the cancellation deadline, HUSZPO has the right to charge the registration fee in full amount.

9. USE OF PERSONAL DATA

HUSZPO collects and processes personal data in accordance with the General Data Protection Regulation (GDPR) and the Personal Data Protection Act for the purpose for which they were obtained and will use them for other purposes. HUSZPO provides a multi-layered notice of personal data processing and enables the exercise of respondents' rights in accordance with the General Regulation in the manner set forth in the Privacy Policy on the Conference website.
